

## CFO PREPARATION FOR THE GADTIMPALA 2018 VALIDATION

The Commission on Filipinos Overseas was shortlisted by the Philippine Commission on Women (PCW) for the **GADtimpala 2018** under the category of **Outstanding Gender-Responsive Government Agency**. GADtimpala stands for Gender and Development Transformation & Institutionalization *through Mainstreaming of Programs, Agenda, Linkages & Advocacies*.

The GADtimpala aims to recognize deserving national government agencies for their outstanding achievement and performance in mainstreaming gender in the bureaucracy, upholding the rights of women and effective implementation of gender responsive programs. It also recognizes the innovativeness and gender-responsiveness of the agencies' programs or projects that contribute to gender equality and women's empowerment, especially those that have made impacts on the lives of women.

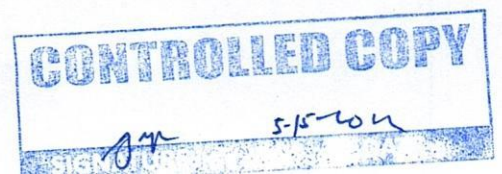
For this purpose, the PCW will conduct Key Informant Interviews (KIIs) on May 21, 2019, Tuesday at 8:30 am to 5:00 pm at the CFO Main Office. The KIIs will validate the Gender Mainstreaming and Evaluation Framework (GMEF) scores relative to the agency's GAD policies, capacity developments, mechanisms, programs, activities, and projects.


